







TERMS OF REFERENCE

INSTRUCTION TO BIDDERS:

The invitation for bids is open to all eligible bidders who may be individual, proprietary firms, partnership firms or companies registered under the company Act, 1956/2013 and meeting the following criteria:

1. Joint Venture is not allowed.

2. Equipment Capabilities:

The bidder(s) shall have equipment in full working order, and must demonstrate that based on known commitments, they will be available for timely use in the proposed contract. The bidder should, undertake their own studies and furnish with their bid, a detailed construction planning and methodology supported with assessment study of requirements of equipment/plants & machineries to allow the Owner/Client to review their proposal. The bidder will ensure his commitment to make the arrangements of the required equipment on the day of commencement or with respect to the progress of the work in phases, as per the instructions of Engineer-in-charge on an undertaking of Rs. 100 stamp paper or of value as approved by Client to be submitted along with the Bid.

The earnest money shall be returned/refunded after the award of the consultancy to all the bidders except the successful bidder who within 15 days of the issue of award letter, has to furnish the performance guarantee (with a validity of 120 days) amounting to 5 percent of the awarded amount in the name of General Manager, Ropeways and Rapid Transport System Development Corporation H.P. Limited, Shimla. The bid security of the successful bidder shall be refunded after the receipt of Performance Guarantee.
6. The bidder shall furnish the bids in two packet cover comprising of Technical bid and Financial bid. The Technical bid shall comprise of all documents required as mentioned on this ITB & Eligibility Criteria.
7. In the financial bid the Bidder shall quote for the Consultancy fee in percentage of the Project cost in the format as per Annexure A, which shall be paid to the selected consultant at different stages on achieving the milestones, as per the Scope of the Work attached, to be submitted in a separate envelope to be superscribed as "Financial Bid". The financial bids of the technically qualified parties shall only be opened. Further, in case Financial Bid is not submitted in separate envelope and is accidentally opened during technical evaluation, the RTDC reserves the right to accept or reject the same without assigning any reasons thereof.

ELIGIBILITY CRITERIA FOR BIDDERS:

To qualify for award of the contract, Bidders are advised to note the minimum qualification criteria specified below;

1. **Company Registration:** The bidder shall be proprietary firms, partnership firms or companies registered under the Companies Act 1956/ 2013 in India and should have established office in India since past 1 year.

2. **Personnel Capability**

Consultant must produce documentary evidence having the following key personnel on their establishment at least six months prior to submission of bid and during the duration of contract and should submit undertaking stating that key personnel or equipment will be deployed on site after award of contract as per necessity and instruction of Engineer in Charge. Key personnel should have experience in similar type of work i.e. in site development, preparation of architectural layout, landscaping and structural design of ropeway infrastructure.

2. Similar nature of Work: The Bidder in its own name should have satisfactorily executed the work of similar nature of Govt./Semi Govt. & Public Sector undertaking in India, during last one year ending last day of month previous to the one in which bids are invited as a prime Contractor. The Bidder should meet any of the following conditions:

- i) As a proof of technical experience/competence, the Bidder should have successfully completed the following in the last one years);
- at least one work of similar nature in individual capacity for a minimum value of 80% of advertised tender value of this work
 - or
 - at least two work of similar nature in individual capacity for a minimum value of 50% of advertised tender value of this work
 - or
 - at least three work of similar nature in individual capacity for a minimum value of 40% of advertised tender value of this work

ii) For judging the technical eligibility and financial capability, only those works which had been executed for the Govt. or Semi Govt. and Public Sector Undertakings in India shall be considered and the Bidder will submit the certificate to this effect from the officer concerned duly signed under the official seal and same should be submitted along with tender documents by all bidders.

iii) Similar nature of work means Civil work of commercial complexes/ offices/ buildings.

Notes:

- i.) The requisite credential certificates/documents should clearly be submitted by the Bidder along with his/their offer to clearly fulfil all the eligibility criteria as mentioned above, failing which the offer shall be summarily rejected.
- ii.) The Bidder shall have to submit his/their offer in corrigendum documents, if any issued, failing which the offer shall be summarily rejected.
- iii.) For verification of documents Bidder has to submit the details of issuing authority and organization like- Postal address, Name, Designation, Office Phone number, Mobile no. and email ID of concerned person along with the soft copies of concerned RFP documents.
- iv.) Bidder needs to present to the Client it's approach and methodology demonstrating its understanding for the Project, Project Plan and Maintenance Plan through a Power Point Presentation (PPT) for technical evaluation.

SCOPE OF WORK

The bidders will be responsible for the following:

- 1 Detailed Survey of the site (both LTP & UTP), soil investigations, Geological investigations & preparation of contour plans and concept plan of the terrain.
- 2 Detailed architectural planning and landscaping of the infrastructure i.e. Lower terminal building and upper terminal building of ropeway.
- 3 Detailed structural design of the infrastructure (including retaining structures, Access road etc) i.e. Lower terminal building and upper terminal building and as per Bureau of India Standards.
- 4 Detailed estimation, costing of civil works along with justification of rates of the infrastructure i.e. Lower terminal building and upper terminal building as per Himachal Pradesh schedules of rates and Delhi Schedule of rates.
