#### TOR FOR CONSULTANTS

#### PROJECT OBJECTIVE

The objective of the assignment is to successful development of Passenger Ropeway from Chamba bus stand to Chaugan Distt. Chamba (H.P.) on **BIS/Hybrid Standards on EPC mode**.

#### SCOPE OF WORK

#### a. Project Report

- Site Topographical Survey and Geo Technical Studies as per prescribed engineering norms
- Carry out detailed topographical survey with DGPS control of the area and make out conceptual plans/ preliminary drawings as required by client, keeping in view the topographical features and functional needs of the location.
- Carry out detailed Soil including Geo-technical investigations (2 No Bore holes at two station locations) to ascertain the Safe Bearing Capacity for design of foundation.

#### Preparation of Architectural Plans and Drawings

- Discussions with client and finalization of project brief, freezing of Conceptual Plan as per the requirement of the client.
- Carry out Architectural design of the ropeway stations keeping in view the need to harmonies with the landscape and other Architectural features existing in the area.
- Preparation of detailed working drawing and specifications.

#### Preparation of Estimates

• The estimates shall be complete, comprehensive and must be supported by detailed Architectural drawings, preliminary structural plans, preliminary lay-out drawings of the various services, detailed drawings and/or specifications for the various components of work involved, details in support of the lump-sum provisions made in the estimate if any, a brief note on the special construction difficulties likely to be



encountered during construction stage etc.

- b. Management of the Bidding Process & selection of the successful bidder: This includes drafting of a short News Paper Advertisement, premarketing, and clarification to prospective bidders, arranging Pre-Bid Meeting, Preparation of Clarifications to the participants, Marketing the project to the national and international equipment supplier, preparation of justification of rates, evaluation of Technical and Financial Proposals.
  - Assisting RTDC in the issuance of Letter of Intent & Award letter to the successful Bidder and execution of Contract Agreement between the successful Bidder and RTDC.

#### c. Construction Supervision:

- Testing and inspection will be carried out mainly based on the technical and procedural standards of the BIS code.
- Inspection of Geo-tech investigations, ropeway substructure works as per design &drawings on relevant standards, all ropeway related electromechanical equipment at work site, erection of complete Ropeway equipment, commissioning, testing as per safety standards & anticollision devices and testing of evacuation equipment practically as per SOP. The reports of inspections at various stages be submitted to RTDC.
- Assist client in mobilization of resources and check CPM of the Contractor.
- Coordination with main Contractors and sub-contractors and rendering technical advice; Holding periodic Progress Meetings and sorting out problems.
- Proof checking of Structure Drawings/ Good for Construction Drawings submitted by Contractor for the construction
- Check Construction Drawings submitted by the Contractor per the requirement of the work.
- Construction supervision, Quality Control and Quality Assurance as per the standard practice.
- Ensure effective coordination between various agencies working at the site and the Architects to ensure timely availability of the inputs required for uninterrupted construction at site all in accordance with agreed programme of the activities.

- Ensuring that the construction is being carried out in accordance with the approved working designs, drawings and specifications and as per Programme laid down in the Contract.
- Ensure quality control of the Work including materials and workmanship, certify measurement of work executed, and make progressive payments based on physical realization / completion of works, as per approved procedure and schedule of payments to Contractors. A Monitoring Committee constituted by client or nodal officer nominated by client will do the routine inspection at site on random basis but the overall responsibility is of the consultant.
- Keeping a close watch on deviations of items beyond prescribed limit, extra items, and substituted items.
- Providing detailed justification for necessity of major changes in terms of design, quantities and specifications etc. & obtain approval thereof from client.
- Provide quick clarifications to design or details that have been provided vide drawings or immediate solutions to clarifications sought by the vendors/contractors.
- Checking of Contractor running bill, certification and assist RTDC in timely payments to the contractor to maintain the cash flow. All measurement of work will be recorded in Measurement books at site by Engineer-in Charge. Checking and certification of contractor's final bills of the works executed and final payments to the contractor.
- Submission of Monthly/Quarterly/Annual Progress Reports and Final Completion Report in the approved or as required by client.

## d. Quality Check & Assurance during Execution Phase:

Check and control of the quality of the execution of the ropeway on site, monitoring of the time schedule, factory acceptance test. In detail this phase will include following items:

- To monitor contractor's supervision of the construction activities as per predetermined inspection test plan;
- Quality planning and quality assurance;
- Quality check and final approval of the ropeway foundations;
- Check of the correct position of all anchor frames and foundation positions;

- Quality check of the foundation reinforcement steel bars and concrete material;
- To review the proposed construction schedules periodically updated by contractors and get it approved from RTDC.
- To review and approve contractors' method statement, erection procedures & work plans;
- To monitor quality of the work being executed through good engineering practices.

#### Measurement of work e.

- Assuming full and overall responsibilities for supervision & quality control for proper execution of all works by contractor who engaged from time to time.
- Identify construction delay and recommend to Ropeways and Rapid Transport System Development Corporation (RTDC), Shimla, remedial measures to expedite the progress.
- To assist the Ropeways and Rapid Transport System Development Corporation (RTDC), Shimla, in arriving at any cost variation and its impact on design during construction stage, related to drawing & design.
- Checking measurement of works at site in full, preparation of bills and submitting the same to RTDC along with quality assurance certificate to that effect as per milestones.

#### f. **Defects Liability Period**

- Settlement of all accounts of the Contractors.
- Witness testing & commissioning of all utilities and certify the same.
- Provide project completion report which shall contain all technical information of the project.
- Co-ordinate with Contractors and arrange for user operation & maintenance manuals.
- Rectification defects through Contractor during the 'Defect Liability Period (DLP) of particular component of the Project' which will be 12 months. The month of DLP of Particular Component of the Project will start from the date of Completion of project component.
