IV. Eligibility Criteria:-

a) The Bidder must have done consultancy services (preparation of Tender document/bid process management/concession agreement for Passenger Ropeway Projects during the last five years of value:-

- 1) One project not less than 172 Cr. or
- 2) Two projects not less than 100 Cr each.
- 3) Three projects not less than 50 Lakh each.

b) Bidder must demonstrate its strength by submitting detailed credentials of expertise of the team members (detail of Team members to be annexed with Bid) (Technical, Financial, Legal Expert) available with him to do this specialized assignment i.e. Experience in Similar projects, details of successful projects, Credentials of team for doing this assignment and details of other EPC projects successfully undertaken (Acceptable to the RTDC) to be submitted in separate envelope, which should be subscribed as **“Technical Bid”**.

The financial bids of the technically qualified parties shall only be opened. Further, in case Financial Bid is not submitted in separate envelope and is accidentally opened during technical evaluation, the RTDC reserves the right to accept or reject the same without assigning any reasons thereof.


