ELIGIBILITY OF BIDDERS:-

1. The bids shall be accepted from the Principle Manufacturers/ Authorized Dealers only.

2. Financial Capability:-

The Bidders should have average annual sales turnover of INR 10Crores respectively for last three years (prior to the year of bid opening). The Bidder shall furnish documentary evidence in the form of financial statements duly certified by Chartered Accountant for the last 3 years. The year wise Annual turnover shall be tabulated on format as per Performa-I.

3. Experience and Technical Capacity;

The Bidder shall furnish documentary evidence to demonstrate that it meets the following experience requirement(s):

- a) The Bidder should have supplied at least 10 similar Vehicle or equivalent to that during past 5 years preceding current financial year



out of which at least 5 nos. should have been supplied to any Individual/ PSU's/Central/State Govt. departments in India. In its support bidder should submit authenticated copies of supply orders along with corresponding execution/commissioning certificates issued by Purchaser of the equipment. The Abstract information in this regard may be furnished on format as per Performa-II.

- b) The bidder shall have an established dealer network, after sales and service support in the state of Himachal Pradesh.
- c) The Executive submitting the bids should have been duly authorized on behalf of the company/organization to submit the bids.
- d) Status of the bidder in the eye of law, such as Proprietorship/Partnership firm/company may also be mentioned.
- e) Even though the bidders meet the above qualifying criteria, they can be disqualified if those firm/Contractor:-
 - i) Has been blacklisted by any Central/State Govt./its Organization and/or;
 - ii) Has made misleading or false representations in the forms, statements, declarations and attachments submitted in proof of the qualification's requirements.

SUBMISSION OF BIDS: -

The submission of the Bids is to be done online in 2 covers:-

- 1) **Cover 1 Technical bid:** shall contain scanned copies of all documents as shown in Annexure 'A'.
- 2) **Cover2 financial bid:** shall contain "BOQ/Financial Bid", where Bidders will quote their offer for each item, as specified in Annexure "B".

SUBMISSION OF ORIGINAL DOCUMENTS:

The bidders are required to submit original Technical bid in sealed cover, security/Earnest Money Deposit (EMD)/Tender Document Fee and other Technical Documents in O/o The Deputy General Manager, Ropeway & Rapid Transport System Development Corporation, US Club Shimla-1, 171001 through **Registered/Speed post** or in person on or before 19/05/2022, failing which the bids will be declared non-responsive.

OPENING OF BIDS:

The Technical Cover shall be opened by authorised officers/committee in the office of The Deputy General Manager, Ropeway & Rapid Transport System Development Corporation, US Club Shimla-1, 171001 on the appointed date and time.

TECHNICAL EVALUATION:

Technical Evaluation shall be done on the basis of Technical specification as per Para "A", Eligibility Criteria as per Para "B", Terms and Conditions and Documents mentioned under Annexure "A" by Evaluation Committee to be constituted by competent Authority. The bidder with incomplete documents and not meeting the criteria therein shall be declared non-responsive and their financial bids will not be opened.

FINANCIAL EVALUATION:

The Financial bids of bidders declared responsive in Technical Evaluation shall be opened and evaluated by the committee to be constituted by the Competent Authority. The Bidder shall be selected on the basis of lowest financial bid offered.



Terms and conditions

1. The bids shall be accepted from the Principle Manufacturers /Authorized Dealers only.
2. Bids shall be accompanied with an Earnest money as shown in the Invitation for Bids (IFB) against item in the shape of fixed deposit/NSC in favour of Deputy General Manager, Ropeway & Rapid Transport System Development Corporation, US Club Shimla-171001, on any scheduled bank payable at Shimla HP.
3. the Tender Document Fee 500/- + GST only, in favour of Deputy General Manager, Ropeway & Rapid Transport System Development Corporation, US Club Shimla-171001 (non-refundable) may be deposited through Demand Draft along with the Tender otherwise the tender may be rejected.
4. The rates may be quoted F.O.R Shimla inclusive of all taxes including GST, Freight charges, Transit Insurance, loading/Unloading etc.
5. Quantities shown in the bid(s) are tentative and can vary as per actual requirement on either side for which no claim shall be entertained.
6. Necessary Literature indicating detailed technical data/specification of the product and attachments should also accompany the Bid(s).
7. The Bid(s) shall remain valid for at least 180 days from the date of opening of bids. If any bidder withdraws his bid before the said period or makes any modifications in the terms & conditions of the tender, the said Earnest Money shall be forfeited besides any other action as per the policy of the Govt. Banning Business Dealing.
8. In case of any information/document found false or fake as furnished by the bidders then department reserves the right to cancel the bid at any time without assigning any reason thereof forfeiting the EMD submitted by the bidder. In addition to above, bidder shall be debarred for minimum one year.
9. Supply is required to be completed within 30 days positively from the date of the supply order and in the eventuality of delayed supplies, the penalty @ 50% of EMD per month subject to a maximum of 100% of




- EMD beyond delivery period of 30 days shall be imposed and deducted from the Earnest Money/performance Guarantee. For any unforeseen eventuality the firm may apply for extension of time beyond 30 days, but it will be sole discretion of this office to accept or decline the same.
10. The Bidding firm shall submit an affidavit to the effect that their firm has not been blacklisted by any state/central department agency.
 11. Warranty period will be 12 months or 1000 hours (whichever is less) from the date of commissioning.
 12. The bidder has to submit an undertaking that they shall continue to provide after sale service/technical support as well as spares up to 10 years from the date of issue of taking over certificate of the equipment from Department on prevailing market rates.
 13. Payment terms: -80% of payment value will be made against documents but on arrival of consignment at destination and balance 20% will be made after successful running of vehicle after one month and to the entire satisfaction of the consignee.
