## PROJECT OBJECTIVE

The objective of the assignment is to successfully undertake Consultancy for preparation of Project Report, Tender Document & P.M.C. for development of passenger ropeway from Taxi Parking to Baba Balak Nath Temple, Distt. Hamirpur (H.P.). The Project shall include but not limited to following scope of work:

### SCOPE OF WORK

## 1) Preparation of Project Report

- a. Site Topographical Survey and Geo Technical Studies as per prescribed engineering norms.
- Carry out detailed drone survey of the area and make out conceptual plans required by client, keeping in view the topographical features and functional needs of the location, with respect to the buildings if any, already existing at site, utilities etc.
- Topographical surveys with DGPS control.
- Carry out detailed Soil including Geotechnical investigations to ascertain the Safe Bearing Capacity for design of foundation (one each at all terminal location).
- Study of existing traffic data and projection for the ropeway.

### b. Preparation of Plans and Drawings

- Discussions and finalization of project brief, freezing of Conceptual Plan as per the RTDC requirement.
- Carry out general architectural planning/design of the LTP. UTP &intermediate terminal points (if any) keeping in view the need to harmonize with the landscape and local architectural and features of the buildings already existing in the area incorporating Solar Passive techniques, wherever applicable.

# c. Preparation of General design & planning as per the architectural drawing approved and available site.

- Preliminary plans for ropeway system/technology on CEN Standard by earmarking location of LTP, UTP & Tower etc.
- Prepare general design of the ropeway infrastructure i.e. Lower Terminal,
   Upper Terminal, and intermediate terminal points if any, as per CEN Standards.



d. Preparation of cost estimates

Prepare cost estimates including costing of civil & electro mechanical components of ropeway infrastructure i.e. Lower Terminal, Upper Terminal, and intermediate terminal points if any, as per Himachal Pradesh schedules of rates and Delhi Schedule of rates.

2) Tender Management:

- i) Preparation & submission of RFP & Contract Agreement Documents: The RFP and Contract Agreement shall have robust contractual framework defining relationships among the various stakeholders, the RTDC, lenders etc. and ensure the correct assignment of risks, duties and rewards.
- ii) Management of the Bidding Process & selection of the successful bidder: This includes drafting of a short News Paper Advertisement, pre-marketing, clarification to prospective bidders, arranging Pre-Bid Meeting, Preparation of Clarifications to the participants, Marketing the project to the national and international CEN Standards equipment supplier, evaluation of Technical and Financial Proposals.
- Assisting RTDC in the issuance of Letter of Intent & Award Letter to the iii) successful Bidder and execution of Contract Agreement between the successful Bidder and RTDC.

3) Construction Supervision:

- i) Testing and inspection will be carried out mainly based on the technical and procedural standards of the BIS/ European/Canadian /American / CEN code.
- ii) Inspection of Geo-tech investigations, ropeway substructure works as per ropeway standards. relevant on drawings electromechanical equipment at work site, erection of complete Ropeway equipment, commissioning, testing as per safety standards & anti-collision devices and testing of evacuation equipment practically as per SOP. The reports of inspections at various stages be submitted to RTDC.

# 4) Quality Check & Assurance during Execution Phase:

- i) Check and control of the quality of the execution of the ropeway on site, monitoring of the time schedule. In detail this phase will include following
- a) To monitor contractor's supervision of the construction activities as per predetermined inspection test plan;
- b) Quality planning and quality assurance;



c) Quality check and final approval of the ropeway foundations;

d) Check of the correct position of all anchor frames and foundation positions;

e) Quality check of the foundation reinforcement steel bars and concrete material;

f) To review the proposed construction schedules periodically updated by contractors and get it approved from RTDC.

g) To review and approve contractors' method statement, erection procedures & work plans;

h) To monitor quality of the work being executed through good engineering practices.

### 5) Measurement of work

- a) To assist the Ropeways and Rapid Transport System Development Corporation (RTDC), Shimla, in arriving at any cost variation and its impact on design during construction stage, related to drawing & design.
- b) Checking measurement of works at site in full, preparation/verification of bills and submitting the same to RTDC along with quality assurance certificate to that effect as per payment milestone completed giving complete details of item wise quantities executed at site.


