



**PROJECT OBJECTIVE**

The objective of the assignment is preparation of PPR for development of ferry service from Bhakra Boat Ghaat to Kosarian Boat Ghaat to connect Sh. Naina Devi Ji Temple & Shahtalai/Deotsidh Temple via Gobind Sagar reservoir on PPP mode

The Projects shall include: -

**1. Preparation of Preliminary Project Report (PPR): -**

- a. Detailed Survey of the site and preparation of contour plans of the terrain.
- b. Architectural planning of ferry service i.e. Terminal Stations and Intermediate Stations if any.
- c. General design & Planning of the ferry service i.e. Terminal Stations and Intermediate Stations if any as per relevant standards.
- d. Complete Preliminary estimation and costing of civil works, Terminal Stations and Intermediate Stations if any, as per Himachal Pradesh schedules of rates and Delhi Schedule of rates & Electro & Mechanical equipment installing execution and commissioning.

**SCOPE OF WORK**

**1) Preparation of Preliminary Project Report (PPR)**

**1. Site Topographical Survey and as per prescribed engineering norms**

- Carry out detailed survey of the area and make out conceptual plans as required by client, keeping in view the topographical features and functional needs of the location, with respect to the buildings if any, already existing at site, utilities etc.

- Study of existing traffic data and projection for the ferry service.


