

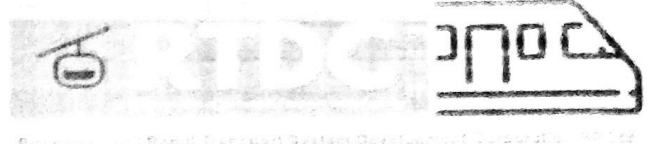

- III. In the financial bid the Bidder shall quote for the Consultancy fee in absolute amount per month which shall be paid to the consultant in the first week of every succeeding month.





7. Any other work assigned.


TERMS AND CONDITIONS

 3. In case the consultant is not willing to carry on his/her services, he shall also promptly notify the same in writing with a notice period of one month.
 4. The engagement shall be for a period of one year which may be extended on the discretion of the Competent Authority.
 5. The services will normally be performed in Ropeway & Rapid Transport System Development Corporation (RTDC) H.P. Ltd. Office at Shimla 171009. However, the Consultant may be required to be at project sites as and when required.
