

1. Education and other qualification
 - 1.1 (i) Matric Pass from a recognized Board of School Education.
(ii) Must possess valid driving license for plying of heavy/light vehicle in hilly terrain.
 - 1.2 Desirable: -Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.
 - 1.3 The candidate should be Bonafide Himachali.
2. **Age Limit:** - The age of the applicant should be between 18 to 45 years as on 1-1-2024. The relaxation in upper age limit is permissible upto 5 years in case of SC applicant as per instructions of the Government of H.P.
