NOTIFICATION

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor of Himachal Pradesh, in consultation with the Himachal Pradesh Public Service Commission, is pleased to make the following rules further to amend the Himachal Pradesh, Department of Personnel, Driver, Class-III (Non-Gazetted) Common Recruitment and Promotion Rules, 2017 notified vide this Department Notification No. Per(AP)-C-A(3)-4/2010 dated 23<sup>rd</sup> October, 2017, namely:-

No. 15, the following shall be substituted, namely:<br>"Selection for appointment to the post in the case of direct appointment shall be on the basis of driving/skill test of 85 marks format, template and guidelines to be notified by the State Government followed by evaluation based on the parameters as specified in Appendix-I attached to these rules. The Committee to conduct driving/skill test shall be headed by a senior officer/nominee of the concerned department and invariably include atleast two technical personnel out of Assistant Engineer (HPPWD-Mechanica |

Wing), Works Manager/Driving Instructor/ Foreman of HRTC and Motor Vehicle Inspector”

- (b) For existing provisions against column number-15-A(IV), the following shall be substituted, namely:

“Selection for appointment to the post in the case of contract appointment shall be on the basis of driving/skill test of 85 marks format, template and guidelines to be notified by the State Government followed by evaluation based on the parameters as specified in Appendix-I attached to these rules. The Committee to conduct driving/skill test shall be headed by a senior officer/nominee of the concerned department and invariably include atleast two technical personnel out of Assistant Engineer (HPPWD-Mechanical Wing), Works Manager/Driving Instructor/ Foreman of HRTC and Motor Vehicle Inspector”.

## Appendix-I

(i)	Weightage for the minimum educational qualification, prescribed in the Recruitment & Promotion Rules.  {Percentage of marks obtained in the educational qualification would be multiplied by 0.02. For example, an individual has secured 50% marks in the required educational qualification, he/she will be allowed 1 marks (50x0.02=1)}	2 (two)
(ii)	Belonging to notified Backward Area or Panchayat, as the case may be.	1 (one)
(iii)	Land less family/family having land less than 1 Hectare to be certified by the concerned Revenue Authority.	1 (one)
(iv)	Non-employment Certificate to the effect that none of the family members is in Government/Semi-Government service.	1 (one)
(v)	NSS (atleast one year)/certificate holders in NCC/ The Bharat Scout and Guide/Medal winner in National Level sports competitions.	1 (one)
(vi)	BPL family having annual income (from all sources) below ₹40,000/- or as prescribed by the Govt. from time to time.	2 (two)
(vii)	Widow/divorced/destitute/single woman.	1 (one)
(viii)	Single daughter/Orphan	1 (one)
(ix)	Experience upto a maximum of 5 years in Govt./Semi-Govt. Organization relating to the post applied for (1 marks only for each completed year)	5 (five)
